Chair's report

Kia ora koutou,

From day one, the Paris 2024 Paralympic Games lived up to the pre-Games prediction of IPC President Andrew Parsons, as the most spectacular in the history of the Paralympic Movement.

By almost every metric the Paralympics set new benchmarks in 2024 – we saw a record number of broadcasters, a record number of media on site and the most nations competing at a Paralympic Games.

Beyond the statistics, Paris 2024 will leave a long-lasting legacy and that is what the Paralympic Movement is all about. **Change Starts with Sport**. Inspiring the growth in pathways from participation to podium in sports worldwide for those with a disability and leveraging the power of Paralympians and Para sports to change outdated attitudes towards disability.

Back here in Aotearoa New Zealand the Paralympic Games captured the hearts and minds of the public like never before, evidenced by record-breaking engagement, including the most extensive broadcast coverage, with more than two million Kiwis – over 40 percent of the population – tuning in to watch. All of which is central to inspiring the next generation and seeing much needed change in perceptions.

Paralympics New Zealand (PNZ)'s marketing campaign promised to give you 'Something To Talk About' and our NZ Paralympic Team did just that. The NZ Paralympic Team of 24 athletes comprising of ten debutants, across eight Para sports – performed with legendary Kiwi mana and pride, securing nine medals and setting one Paralympic record, four Oceania records, 11 national records and 12 personal best performances during 11 unforgettable days of competition in the French capital.

Thank you to all our Paralympians for your performances and the change you inspire.

While the medals and number of Para sports we compete in are not all that matters, they are a key indication that there are more pathways in a greater number of Para sports for a disabled person. **Signs are encouraging.** We have seen an eightfold increase in registrations of interest by potential Para athletes this year and more than 400 schools up and down the country registered to take part in Seeing is Believing, PNZ's Paralympic Education Programme delivered with the support from our Major Partner Toyota.

I have little doubt that the conversations prompted by Paris 2024 can continue to change perceptions of, and opportunities for, those with disabilities in Aotearoa New Zealand, and that momentum can be maintained looking ahead to Milano Cortina 2026, Los Angeles 2028 and beyond.

A huge credit to our PNZ Staff and existing and new partners, for contributing to achieving a positive financial result, particularly in a Paralympic Games year. As we forecast ahead to 2032, and with the financial landscape remaining uncertain, we have the challenge to broaden our revenue models and continually review our costs, to focus on what matters most.

Thank you to the PNZ Athletes' Council for all their efforts and in particular I would like to thank inaugural Chair, Paralympian #213 Sarah Ellington and Paralympians #148 Michael Johnson MNZM, and #202 Jacob Phillips who step down, acknowledge Paralympian #195 Anna Grimaldi MNZM who has been re-elected, and welcome Paralympians #158 Adam Hall MNZM and #211 Danielle Aitchison who have been elected to the Council. With the success of the PNZ Athletes' Council, we now want to formalise a place for Para athlete representation on the PNZ Board and this is part of recent consultation to amend the PNZ Constitution, in line with other changes needed with the new Incorporated Societies Act.

I would also like to acknowledge the leadership and efforts of the PNZ Board, CEO Greg Warnecke and the PNZ Staff who continue to drive forward our vision and strategy.

A particular note of thanks to our valued commercial and funding partners, our delivery partners High Performance Sport New Zealand, Sport New Zealand, our PNZ members National Sports Organisations, Parafed and similar organisations, and associate organisations – we could not do what we do without you.

Finally, I would like to thank our PNZ Patron, Her Excellency The Right Honourable Dame Cindy Kiro, GNZM, QSO, Governor-General of New Zealand, for her continued support.

CEO's report

Kia ora koutou,

As we reflect on the past year, 2024 might be remembered most for another successful Paralympic Games, but it should also be recognised as a year where significant progress was achieved, advocating, educating and celebrating the Paralympic Movement in Aotearoa New Zealand.

Leading into the Paris 2024 Paralympic Games, Paralympics New Zealand (PNZ) implemented our social change marketing campaign showcasing NZ Paralympians and Para athletes, to give all of Aotearoa New Zealand **#SomethingToTalkAbout**.

At the Paris 2024 Paralympic Games, the NZ Paralympic Team campaign got underway along the famous Champs-Élysées, with Paralympians #164 Cameron Leslie MNZM and #195 Anna Grimaldi MNZM proudly carrying the flag at the Opening Ceremony, representing all of Aotearoa New Zealand, before our Paralympians took to the fields of play at iconic locations, including the Chateau de Versailles and Stade de France.

The NZ Paralympic Team secured nine medals (one gold, four silver, four bronze) across three sports - Para athletics, Para canoe and Para cycling - before the full stop was put on a memorable Paralympic Games as Paralympians #208 William Stedman and #222 Nicole Murray, represented New Zealand as flagbearers at the Closing Ceremony. With the support of unprecedented coverage by TVNZ, anchored by Paralympian #166 Dame Sophie Pascoe DNZM, our NZ Paralympic Team demonstrated that they are **#WorthTalkingAbout** with their performances uniting New Zealanders, and surpassing Paralympic Games viewing and engagement metrics in the process.

PNZ enjoyed significant reach, engagement and recognition via our social channels. As this content was shared by our incredible partners and supporters, this helped to generate unparalleled interest in our Paralympians. Thanks to media partners TVNZ, NZME, Attitude and Lumo for taking our Paralympians to more people than ever before and connecting with the future generation of Para athletes and Paralympians.

It was also a year of change. At the completion of 2024, PNZ supported the transition of the Para cycling programme to Cycling New Zealand, further strengthening the integration of Para sports with National Sports Organisations. We thank the many Para athletes and support staff that contributed to the success of the programme over many years. After winning medals at Paris 2024, Para cycling in Aotearoa New Zealand looks in great shape to enjoy continued success on the global stage.

PNZ will continue into 2025 as the National Sports Organisation for Shooting Para sport, as we look to grow interest and participation. It is also fitting to recognise Paralympian #148 Michael Johnson MNZM, who competed at a record-equalling sixth Paralympic Games in Paris. Michael is the Programme Lead for PNZ's Shooting Para Sport Programme.

We welcomed Bupa – a new Official Partner, joining Major Partner Toyota, Official Partners Harvey Norman and Cadbury, Community Partners ACC and Sport NZ, and our extended partner whānau of Team Supporter and Official Suppliers. Your combined support is valued immensely and provides the critical foundation for PNZ to deliver across Para sport programmes and initiatives, including sending our NZ Paralympic Team to each Paralympic Games.

Thank you also to our PNZ Members, funders, and donors, for contributing so much to this success. And to the PNZ Staff, PNZ Athletes' Council and PNZ Board – the heights which have been scaled in 2024 would not have been possible without your combined energy and commitment. Transforming lives through Para sport relies on the contributions of many. The platform which was created by the Paris 2024 Paralympic Games and the performances of our NZ Paralympic Team provide the foundation for continued growth across Para sport in Aotearoa New Zealand.

Moving into the next four-year Paralympic Games cycle, PNZ, our NZ Paralympians and Para athletes will challenge Aotearoa New Zealand to continue to **#TalkAboutThis**, with winter and summer Paralympic Games on the horizon.

Athletes' Council Chair's Report

The Paralympics New Zealand (PNZ) Athletes' Council is for Paralympians and Para athletes who have competed in international competition in the past 12 years. We are for the Para athletes, set up by the Para athletes.

Reflecting on 2024, all eyes were undoubtedly focused on the pinnacle event for the year - the Paris 2024 Paralympic Games. I was watching from home and found the TVNZ broadcast to be amazing. With Paralympian #166 Dame Sophie Pascoe DNZM as one of the main presenters of Paris 2024 it made the Games so much more authentic and relatable. Having the insights of our most successful Paralympian leading the broadcast coverage was certainly a significant step in the right direction.

A big congratulations as well, to all our newly pinned Paralympians who competed at Paris 2024. Wear your Paralympian number with honour and pride.

As a Council it has been a hard year to connect in person as many Council members had eyes on Paris 2024 qualification. But we did have some valuable online meetings and two face-toface meetings to round off 2024.

We held our first Para athlete engagement events in March 2024 on the back of the Paris 2024 Roadshows in Cambridge, Auckland and Christchurch. The aim of these events was to grow awareness of the PNZ Athletes' Council, make greater connections in our community and hear the views of Para athletes. We hope to further develop these connections into 2025.

Building our community has continued to be a priority for the Council over the past year. We've grown our contact list of Para athletes by 10%. Meanwhile, our email updates sent following each meeting have continued to receive positive feedback.

November 2024 also saw elections to the PNZ Athletes' Council. While three people stepped down, we saw the re-election of Paralympian #195 Anna Grimaldi MNZM and election of Paralympians #158 Adam Hall MNZM and #211 Danielle Aitchison. Moving forward the Council is in a great position. I wish the trio the best of luck and I'm sure they will build on the fantastic work already done.

From a personal point of view, my term as an inaugural member and Chair of the Athletes' Council has come to an end. It has been a huge privilege to serve on the Council. We started out as a new group in 2021, not quite sure what we were doing or the direction we wanted to go, but over the past three years we have been able to achieve great progress and made a difference by offering an athletes' voice across the work that PNZ delivers.

Statement of Service Performance

Vision

Through Para sport, lives will be transformed.

Paralympics New Zealand (PNZ) is the National Paralympic Committee (NPC) for New Zealand. We are a registered charity and our overall vision is, 'Through Para sport, lives will be transformed'.

As a member of the International Paralympic Committee (IPC), we are part of a worldwide social change movement, which uses the power of sport to positively influence community perceptions of disabled people and to promote a more diverse and inclusive society. To do this, we support and celebrate the achievements of Para athletes at international and national competitions all year round. Every two years, we lead New Zealand teams to the Paralympic Games. We also advocate for sport to become more accessible for disabled people and to support the creation of opportunities to enable greater participation in Para sport.

Values

Leadership

PNZ's strategic leadership and collaborative approach with members and partners will lead to a strengthened Para sport pathway in New Zealand.

Excellence

Excellence at all levels of the Para sport pathway through to the Paralympic Games: quality experiences are paramount.

Advocacy

Championing the right for equal opportunity for all disabled New Zealanders to be involved in sport, ensuring disability awareness is part of the conversation, not an afterthought, and inclusion of Para sport in sport is genuine and authentic.

In compiling the Statement of Service Performance report, management has made judgements in relation to which outcomes and outputs best reflect the achievements of our performance in relation to our Purpose and Mission. Management has also made judgements about which outcomes and outputs would be measured reliably and consistently, and could be supported by evidence that could be independently audited.

Statement of Service Performance

Outcome 1:

Equity is achieved when Para sport is recognised at all levels of sport in New Zealand

Paralympics New Zealand (PNZ) maintains an active presence within the community, promoting recognition of Para sport including developing educational content, supporting Para sport activity including the awarding of grants, and reaching new audiences through hosted events. The Seeing is Believing Education Programme, with support from Toyota, surpassed all expectations in 2024. A year highlighted by the Paris 2024 Paralympic Games, 406 schools across Aotearoa New Zealand signed up to access the educational materials provided as part of the programme. The organisation also surpassed its aspiration to target 50 school visits from Paralympians and Para athletes, as 73 were achieved across the calendar year.

Statement of Service Performance

Outcome 2: A strong and sustainable pathway to the Paralympic Games

The NZ Paralympic Team at the Paris 2024 Paralympic Games comprised 24 Paralympians, plus 41 delegation and support staff. The 24 Paralympians competed across eight Para sports – two more than at the Tokyo 2020 Paralympic Games. Twenty six Para athletes were classified across the calendar year. Nationally and globally, Paralympics New Zealand (PNZ) Para athletes attended 13 competitions. A total of 170 Para athletes are now represented by the PNZ Athletes' Council – a growth of a further 15 Para athletes compared to representation at the end of 2023.

Outcome 3: New Zealand is diverse and fully inclusive

Paralympics New Zealand (PNZ) helps to change the narrative of disability through elevating the achievements of Para athletes, Paralympians, and others in the Paralympic Movement. It does this through awards and recognition, and through expanding the reach of Para sport news through extensive use of PR and social media channels. PNZ also conducts research to measure the impact it has on public perceptions.

Generating revenue from a combination of funding and commercial partners, as well as generous donations from the wider New Zealand community, underpins PNZs ability to offer and successfully deliver all of our programmes, activities, events and preparing and supporting the NZ Paralympic Team at Paralympic Games.

Seeing is Believing, Paralympics New Zealand's (PNZs) Paralympic Education Programme, saw extensive reach and impact following its national launch in October 2023. Emphasis was placed on promoting and driving awareness of the programme within schools throughout the country. PNZ focused on driving teacher registrations throughout term four of 2023, encouraging teachers to explore the online resources, to implement the programme in 2024.

What did we do?

In 2024, Seeing is Believing reached significant milestones that highlight its growing influence, awareness and exposure of Paralympians, Para athletes and the Paralympic Movement across Aotearoa New Zealand and beyond. 406 schools registered nationwide across all 16 regions in Aotearoa New Zealand demonstrating widespread engagement and a shared commitment to building more inclusive classrooms and communities.

Additionally, PNZ successfully released a two-part Paris 2024 Unit with part one released at 100 days to go and part two a week out from the Opening Ceremony of the Paris 2024 Paralympic Games. These units connected the excitement of Paris 2024 to classroom learning. It captured the imagination of learners and teachers alike, combining Para sport, storytelling, and inclusion to bring the values of the Paralympic Movement to life. The second unit released also featured a 'Something To Talk About' module, connecting learners with the three commercials featured in the PNZ marketing campaign, and the long form interviews of Paralympians.


During this time the programme saw a surge of a further 200 schools register in the month leading up to and during the Paralympic Games, showing a huge interest in aligning learning with both the Paralympic Games and Olympic Games simultaneously. Although designed for Year 1-6 learners, the programme catered to a diverse age range, spanning from early childhood education through to secondary school. The adaptability and extensive resources, all connected to the New Zealand Curriculum, allowed schools to tailor content and delivery to meet the school values and unique needs of learners.

The impact

Inspiring the lives and minds of tamariki, teachers and the community

In 2024, Seeing is Believing has continued to transform the way educators perceive and approach inclusion and disability within their classrooms and helped to shape and change perceptions of disability for learners. Through participation, meaningful dialogue, and real-life experiences supported through the resources, tamariki have gained a deeper understanding of diversity and how they can celebrate their own differences.

Exposure and awareness

Only 59 schools out of 406 registered stated they had previously covered the Paralympic Games/Paralympic values/ Paralympic Movement as a unit or focus.

Shifting perceptions

94% of schools who provided feedback noticed a change in the attitudes/ perceptions of learners in their classroom towards disability, Para sport and the Paralympic Games.

Enjoyment of resources

Over 80% of respondents rated their learner enjoyment as five out of five stars.


Building connection

This year, Seeing is Believing strengthened its reach and impact as PNZ achieved meaningful collaborations with several key organisations and communities. This included the Sport New Zealand Healthy Active Learning Team, Parafeds or similar organisations and the Halberg Foundation by promoting inclusive sports opportunities, empowering Para athletes and enabling more students with disabilities to participate in physical activity. PNZ was also able to deliver workshops alongside other disability organisations including the Halberg Foundation and Special Olympics New Zealand to increase reach and education such as the HALO (Healthy Active Learning Opportunities) workshops and lectures at AUT University.

Para Sport Champions are Paralympians or Para athletes who bring the Paralympic values of determination, courage, inspiration, and equality to life through their actions and achievements. The Harvey Norman Para Sport Champions initiative as part of Seeing is Believing, has had an incredible first full year in schools around the country.

A total of 21 Paralympians and Para athletes, across nine Para sports, brought the programme to life through 73 school visits in 2024. Their visits have had a huge impact on more than 10,000 tamariki and ākonga. A total of 71 schools rated their Para Sport Champion visit as five out of five stars. The impact

The visits from Harvey Norman Para Sport Champions were among the most impactful elements of the Seeing is Believing programme this year. These Para athletes brought their stories of determination, courage, and inspiration over adversity directly to classrooms across the country, leaving a lasting impression on thousands of children. Each visit was tailored to the story of the individual Para Sport Champion. Some delivered interactive sessions while others delivered to large group assemblies, captivating hundreds of learners.

For many tamariki and akonga, these encounters were transformative. Hearing firsthand from individuals who have overcome barriers helped to break down stereotypes about disability and foster a deeper understanding of the Paralympic

Movement. Many learners were inspired to view their own challenges differently, with many expressing newfound motivation to pursue their dreams regardless of obstacles. One young learner at Balaclava School in Dunedin was quoted after their own diabetes diagnosis - "If Bailley can cope with her disability, then I can cope with my diabetes" highlighting the true impact this programme and these Para athletes had on their audiences.

Teachers reported a noticeable shift in learners perceptions and attitudes, with increased empathy, curiosity, and respect toward others. The Para Sport Champions' stories also sparked rich classroom discussions and the importance of having goals, embedding the values and messaging within the Seeing is Believing programme into the learners' daily lives.



Regional Community Para Table Tennis Pilot




Paralympics New Zealand (PNZ) staged a regional community Para sport pilot with Table Tennis New Zealand, Disability Sport Auckland, ParaFed Canterbury, Parafed Waikato, Waitematā Table Tennis, Table Tennis Canterbury and Waikato Table Tennis from May-July 2024. The organisations collaborated to co-design and develop the pilot to improve the level of access to new and existing Para table tennis opportunities for disabled New Zealanders and enhance the capability of stakeholders to offer inclusive and quality community Para table tennis experiences in Auckland, Canterbury and Waikato.

The pilot outputs included an eightweek programme and a resource manual named 'Serve, Spin, Smash!'. The programme leveraged shared learnings and best practices from two previous pilots to enhance the operating approach for Para table tennis. This resulted in significant engagement and increase in participation as people with physical, vision and intellectual impairments interacted together. "

Before this programme I had never participated in Para sport but I have had a disability for eight years. This programme has opened my eyes to the possibilities out there for people with disabilities.

Following the evaluation of the pilot, Waikato Table Tennis Association introduced a Para table tennis membership option and integrated Para table tennis into their open tournament in order to make it attractive and welcoming for new members with health conditions and/or impairments. Further collaboration also resulted from the programme as one Parafed explored a joint funding application with a Special Olympics New Zealand club for combined sport sessions in their region.

The pilot gave Table Tennis New Zealand the ability to strengthen connections and gain better appreciation for regional differences while reinforcing their commitment to inclusion. This commitment provides more opportunities and quality experiences for all, leading to the integration of new coaches and officials frameworks, and ensures that Para table tennis pathways are visible from community through to high performance. This pilot is expected to have an ongoing impact as the operating approach and best practices can be adopted in other regions that wish to provide Para table tennis opportunities for disabled people.

Awards and honours

Paralympian Nicole Murray shortlisted for major global Laureus Award

Paralympian #222 Nicole Murray was shortlisted for a prestigious Laureus World Sports Award for her outstanding achievements at the 2023 World Para Cycling Track Championships when she won three medals.

First held in 2000, the annual Laureus World Sports Awards is regarded as the premier global sporting awards ceremony.

The Ngāhinapōuri-raised Paralympian was shortlisted for a Laureus Award in the World Sportsperson with a Disability category.

Nicole is one of the world's top Para cyclists by world ranking. A left-hand amputee from a childhood accident, she competes in the C5 sport class where she snared Omnium gold, Individual Pursuit silver and 500m Time Trial bronze at the 2023 Para Cycling Track World Championships in Glasgow.

At the Paris 2024 Paralympic Games, Nicole won a bronze medal in the Women's C5 3000m Individual Pursuit.

PNZ Order of Merit

Paralympics New Zealand (PNZ) awarded the late Paralympian #13 Eve Rimmer BEM and the late Paralympian #17 Neroli Fairhall MBE a PNZ Order of Merit for their outstanding service to PNZ and Paralympic sport in Aotearoa New Zealand.

Eve, who passed away in 1996, was a trailblazer for Para athletes and a fervent advocate for disability rights, who became a household name in Aotearoa New Zealand through her outstanding sporting career.



Across four Paralympic Games, Eve won 14 medals – 11 in Para athletics with eight of them gold. Her total medal haul has only been surpassed in recent years by Paralympian #166 Dame Sophie Pascoe DNZM.

After a car accident at 15 left Eve paralysed, she found freedom in sport and enjoyed a stunning career. A passionate advocate for disability rights she served as a national councillor on the NZ Paraplegic and Physically Disabled Federation (now PNZ) and established several sporting clubs in the central North Island with Paralympian #14 Jim Savage MBE. She organised the Games for the Disabled in Whakatāne, later renamed the Eve Rimmer Games and also founded the Disabilities Resource Centre in Whakatāne, constantly lobbying for better wheelchair access.

Neroli, who was paralysed from the waist down following a motorbike accident at the age of 24, enjoyed an historic sporting career competing at both the Paralympic Games and Olympic Games.

A four-time Paralympian she claimed Para archery gold at the Arnhem 1980 Paralympic Games before winning a gold medal at the Brisbane 1982 Commonwealth Games.

She made headlines around the globe competing as a disabled athlete at the Los Angeles 1984 Olympic Games.

She represented New Zealand in Para archery at two more Paralympic Games – in Seoul 1988 and Sydney 2000 - and became an administrator for disabled sport and coached elite-level athletes. Neroli passed away in 2006.



In Memoriam

Jim McKie

Paralympics New Zealand (PNZ) Order of Merit recipient Jim McKie passed away on the 27 May 2024. Jim was recognised for his outstanding service to Paralympic sport and PNZ in 2001 when awarded a PNZ Order of Merit. At that time, he was also inducted as a ParaFed Canterbury Life Member.

Jim was the first ever CEO of the NZ Paraplegic and Physically Disabled Federation, which later became PNZ in 2007. In the role of Secretary he took the first ever New Zealand Paralympic Team to the Tel Aviv 1968 Paralympic Games.

During an interview with Jim in 2018 he said: "The Tel Aviv 1968 Paralympics was an incredible learning experience for both athletes and management. These Paralympics provided a platform for what we now know as the Paralympic Movement and PNZ in New Zealand today."

Phil Humphreys MNZM

Phil Humphreys MNZM, 78, passed away on 22 December 2024 after more than 40 years of service to the community, including to many with a disability. A PNZ Order of Merit recipient and ParaFed Canterbury Life Member, Phil was a Board member of ParaFed Canterbury for 27 years and served as Chair for several years.

Instrumental in introducing Wheelchair rugby to New Zealand in the early 1990s he was a regular volunteer at Wheelchair rugby events. A former Navy physical training instructor he assisted people with disabilities in pursuit of sporting and recreational activities. He also coached many disabled athletes, including Paralympians.

In early 2024 he was named a Member of the New Zealand Order of Merit (MNZM) for Services to people with disabilities and sport.



The Team (both Paralympians and Support Staff) were gifted pounamu pendants and the pendants were put around the Mauri stones (touch stones) which created an environment connecting our people and helped them understand what makes us different to all other competing nations.

A successful campaign began in January 2024 with the UCI Road World Cup event in Adelaide, Australia. New Zealand sent a large team of ten Para athletes (some community supported) to South Australia, the primary event that Paralympics New Zealand (PNZ) targeted to earn Paris 2024 qualification slots.

The event also served as an opportunity for Paralympian #229 Devon Briggs to undergo an International Classification review where he was confirmed as a C3 Para athlete.

In March 2024, New Zealand enjoyed a stunning UCI Para Cycling Track World Championships in Rio winning nine medals - highlighted by gold for Devon.

Paralympian #222 Nicole Murray travelled to Madrid, Spain as a finalist at the Laureus Awards in the *Sportsperson of the Year* with a Disability category. The timing of these awards dovetailed nicely into one of the three UCI Road World Cups in Ostend, Belgium and then two days after this event all nations were able to participate in a closed road event and experience the Paris 2024 Paralympic Games road course. Nicole was able to video the circuit and once home presented course notes to all Team members and Paris 2024 hopefuls.

To round out the 2024 season, Paralympian #220 Eltje Malzbender was the sole Kiwi in action at the UCI Road World Championships in September 2024 in Zurich, Switzerland. Eltje rode well to secure bronze medals in the Women's T1 Time Trial and Women's T1 Road Race. This event, like the UCI Glasgow Super World Championships in 2023, were ground-breaking with the Para cycling programme fully integrated with the wider cycling event programme.

DOMESTIC COMPETITIONS

The Shooting Para Sport Programme enjoyed a good year. The goal of two quota plus one bipartisan quota slots with three Para athletes was achieved – Paralympian #148 Michael Johnson MNZM, #204 Greg Reid and #236 Neelam O'Neill earning selection and competing for the NZ Paralympic Team at the Paris 2024 Paralympic Games. This was a positive step forward for the programme with only one New Zealand Paralympian representing Shooting Para sport at the Tokyo 2020 Paralympic Games.

Besides Michael, Greg and Neelam, Natalie Brunzel and Paralympian #107 Grant Sharman MNZM also featured as part of the Paralympics New Zealand (PNZ) High Performance programme in 2024.

Five New Zealand Para athletes competed at the New Delhi World Cup event in India in March 2024 with Michael and Greg securing quota spots for the Paris 2024 Paralympic Games.

Two new Para athletes joined the North Island Development group in Andrew Fairweather (Waikato) and Eligh Fountain (Northland). The Christchurch region has also performed well in its Shooting Para Sport Programme with between 12 to 15 Para athletes actively competing.

Twelve club competitions took place in Auckland and a further two in the Canterbury region. Five training camps took place at Mt Eden in Auckland. In November 2024, PNZ applied to HPSNZ seeking support and investment into the Shooting Para Sport Programme for the 2025-2028 cycle. Central to the application was Michael and Neelam as High Performance Para athletes leading through to the LA 2028 Paralympic Games, supported by initiatives to grow the wider Shooting Para Sport Programme.



PNZ Classification Programme



Classification Management

Paralympics New Zealand (PNZ) contributed to 26 classifications in 2024 with oversight of the Shooting Para sport, Para cycling, Intellectual Impairment and Vision Impairment classification programmes. The number classified in 2024 was lower than previous years however this is common in the year of a summer Paralympic Games.

Classification Training

In April 2024, PNZ hosted the annual classifier forum in Auckland with 16 classifiers in attendance. The training was a great success with 16 Para sports and organisations represented, multiple speakers and key takeaways to be implemented. This annual training is an integral component of PNZ's engagement in NSO classifier development and connecting the network to share ideas, best practice and key international updates.

Through HPSNZ Prime Minister Scholarship funding, PNZ supported four classifiers to undertake classifier training overseas this year. To ensure this funding is fully utilised in the coming year, PNZ will work with NSOs to identify new opportunities to recruit, support and develop classifiers.

Virtus

As a member of Virtus, PNZ continues to manage the eligibility verification programme for NSOs and Para athletes with an intellectual impairment. As the awareness and opportunities within Virtus grow, PNZ will strive to streamline internal processes and support NSOs.

The year ahead

Key classification projects for 2025 include review of the overall PNZ classification programme and PNZ Para Athlete Classification Code and Standards. PNZ plan to maximise NSO classifier training opportunities and work closely with NSOs to ensure their individual classification programmes are both compliant and seamless for the Para sport community.

International update

2025 IPC Classification Code

In May 2024, the International Paralympic Committee (IPC) Extraordinary General Assembly approved the new 2025 IPC Classification Code following a three-phase consultation process of the 2015 IPC Athlete Classification Code. Implementation of the new IPC Classification Code is in effect from January 2025 for summer Para sports and July 2026 for winter Para sports.

2024 IPC Annual Classification Meeting

Kristin Farrell, PNZ Senior Manager, Sport and Pathways represented PNZ at the IPC Annual Classification Meeting at IPC Headquarters in Bonn in October 2024. PNZ representation at this annual meeting is key to growing connections within the classification community and collaborating on initiatives which will support NSO classification programmes.

The Para Sport Collective enjoyed a very successful year in 2024. Intake 1 participants, including Para athletes and coaches, 'graduated' in March 2024 after a year on the programme, and the feedback was overwhelmingly positive.

Participants reported that they finished the year feeling connected, confident, with increased knowledge and skills, and with an awareness of opportunities along the Para sport pathway. They also felt confident in advocating and promoting Para sport.

This translated into:

Three Para Sport Collective participants training to become Para Sport Champions for the Seeing is Believing Paralympic Education Programme.

- Four participants standing for election to the PNZ Athletes' Council.
- Other advocacy examples include a number of Para Sport Collective participants volunteering to be involved in a 'focus group' for Drug Free Sport New Zealand (now part of the Sport Integrity Commission Te Kahu Raunui) to make their education content more accessible.

Participants have remained well connected, with three online "reconnects" as well as celebrating successes, and sharing and supporting each other through their individual Para sport journeys.



Furthermore, from Intake 1, Paralympian #233 Louise Duncan, Para athlete Ben Westenberg, and coaches Marianne Loh and John Tuki, were selected to the NZ Paralympic Team for the Paris 2024 Paralympic Games, which was a proud moment for the Para Sport Collective whānau.

The conclusion of Intake 1 left little doubt that the Para Sport Collective has a very important role to play in strengthening the Para sport pathway.

Intake 2 was then nominated and selected with 25 Para athletes, 12 coaches and two National Sports Organisation observers featuring. This group got underway with their first in-person camp in June 2024.

These were followed by a second twoday in-person camp, on 30 November to 1 December 2024, which included practical nutrition and injury minimisation sessions, a media training session, providing a valuable follow on from the online theory introductions across these areas of performance support.

Camp 2 concluded with an insightful and entertaining Q & A session with Paralympian #164 Cameron Leslie MNZM, Paralympian #205 Jesse Reynolds, and Swimming New Zealand Paralympic Programme Lead Simon Mayne.

Looking ahead, Intake 2 will finish their time on the programme in mid-2025, and each participant will leave connected, with increased confidence, skills and knowledge, and with an in-depth individual performance plan, including a clear understanding of who needs to be in their support circle to ensure they can enjoy success and reach their potential.

PARA SPORTS EXPERIENCED IN NZ

Paralympics New Zealand (PNZ) continued to collaborate with Parafeds and similar organisations to better understand, support and connect disabled people to an increased number of community Para sport opportunities. With the help of all Parafeds and similar organisations, PNZ was able to update the community Para sport database. This continues to grow as a greater number of mainstream sports organisations along with Parafeds and similar organisations deliver to disabled participants. In 2024, 215 community Para sport opportunities were identified in New Zealand, an increase on 177 in 2023.

Co-designing Shared Initiatives

PNZ held individual dialogues with all 11 of PNZ's Parafed members regarding future work with Parafeds on Shared Initiatives and held a joint discussion with the Parafed Network Steering Group to determine potential next steps. The Shared Initiative was defined as "PNZ invite Parafed, NSO and Associate members to work together with PNZ in developing and improving the visibility of Para sport opportunities and Para athlete experiences".

This was followed by eight online working sessions with nine Parafeds and similar

organisations, along with Blind Sport NZ and the Halberg Foundation which led to the identification of potential workstreams. Parafeds supported one workstream that resulted in the production of a sport action plan template to support Parafeds to share with Regional Sport Trusts RSTs and implement in planning sessions with RSOs/clubs/other organisations to enable co-design and delivery of sport to disabled people in a mainstream setting.

LevelUp is a series of nine free online education modules to help coaches of all levels gain confidence, knowledge, capability to coach and support Para athletes. The modules feature New Zealand Para athletes, and cover topics such as the Paralympic Movement, terminology, classification, and coaching considerations for the eligible Para sport impairments. Designed to complement sport-specific coach development provided by the National Sports Organisations (NSOs), the LevelUp modules can be completed in the coaches' own time on Sport Tutor.

With the support of Community Partner ACC, Paralympics New Zealand (PNZ) has been able to update the content to ensure its relevance, and drive marketing and advertising initiatives to reach wider audiences. PNZ has collaborated with Snow Sports NZ, Athletics NZ, Basketball NZ, Equestrian Sports NZ, Swimming NZ, Table Tennis NZ to create tailored

messaging to encourage uptake of the education opportunity. NZ Riding for the Disabled Association became the first organisation, to integrate LevelUp content onto their Learning Management Systems, while Table Tennis NZ became PNZ's first NSO Member to integrate LevelUp.

Over 350 individuals have signed up for LevelUp since its launch in August 2023, and it will continue to be promoted through NSO specific coaching and education frameworks to reach more people. In 2024, 257 registered for the course, where 151 had completed at least one course (two modules) and 72 had completed both courses (nine modules). As coaches apply the LevelUp learnings in their practices. PNZ intends to evaluate the impact of the course and understand how it has influenced coaches to work more effectively with Para athletes.

Commercial partnerships

Paralympics New Zealand (PNZ) commercial partnership activity throughout the year focused on engagement with the Paris 2024 Paralympic Games, collaboration on our "Something To Talk About" (STTA) marketing campaign and key PNZ community programmes; Seeing is Believing (PNZ's Paralympic Education Programme), Para Sport Champions, the Para Sport Collective and the LevelUp Coaching Resource.

Partnerships

Commercial partners play a significant role in supporting PNZ and sharing our campaign messages. Engagement with Paralympians and Para athletes allows partners to experience their stories directly, and by sharing these stories with their networks, contribute to changing perceptions about disability and the transformative impact of Para sport. Toyota New Zealand has been a Major Partner and Official Vehicle Supplier of PNZ since 2017. Toyota has also partnered with the International Paralympic Committee (IPC) as the Worldwide Official Mobility Partner since 2015.



Mondelez with the Cadbury brand, continued as a PNZ Official Partner and the Official Chocolate of the NZ Paralympic Team. A national retail promotion ran in the build-up to Paris 2024, featuring athletes on Cadbury Dairy Milk packs, including Paralympian #210 Lisa Adams. The campaign promoted the valuable work of volunteers in the community. The NZ Paralympic Team brand featured on pack in the Cadbury "Favourite Seasonal Moments" promotion and on the Cadbury "Give a Cheer to a Volunteer" TV commercial. We acknowledge the work of the Mondelez team to celebrate the important role of volunteers in NZ sport.



ACC as Community Partner of PNZ has contributed another active year of partnership impact supporting the Para Sport Collective and the LevelUp coaching resource. ACC has played a key role promoting Para sport participation through its digital channels and active storytelling using video and print stories featuring Paralympians and Para athletes. ACC has helped grow awareness of both the Para Sport Collective and LevelUp supporting initiatives throughout the sports sector and promoting LevelUp at the National Secondary Schools Sports conference. ACC has also introduced PNZ into other ACC partnerships and events, building connections with Auckland Round the Bays, the Waka Ama National Championships and the IronMāori triathlon.

Sport NZ as a Community Partner is a valuable contributor to PNZ. The Sport NZ team has provided marketing and

communications expertise, and support for key commercial initiatives. Sport NZ plays a key role in celebrating Para athletes and the NZ Paralympic Team on social media and created an engaging TikTok campaign sharing personal insights and behind the scenes content with our Paralympians for Paris 2024. Video clips of medallists also featured on Sport NZ social channels during the Paralympic Games. Sport NZ ran the celebratory post Games "Bravoooooooo" billboard campaign, celebrating the nine medals won by the NZ Paralympic Team in Paris and integrating the STTA marketing campaign - "Paralympians, you gave us plenty to talk about".

TVNZ is the Official Broadcaster of the Paralympic Games and delivered the most extensive coverage of the Games to date. Daily coverage from 7.30pm-5am on TVNZ 1, together with Breakfast and 1News coverage - combined with five digital pop up channels on TVNZ+ - delivered the largest ever Paralympic Games viewing audience in Aotearoa New Zealand.



Coverage on TVNZ 1 reached 2.04 million Kiwis – 41.4% of the total 5 yrs+ population of New Zealand. The five TVNZ streaming channels coupled with video-on-demand content coverage on TVNZ+ (in the 13 yrs+ age group) reached 1.39m streams.

TVNZ partnered with PNZ on the STTA marketing campaign, integrating campaign imagery into its broadcast promotion and generously providing advertising time to showcase the STTA commercials. As a result, this partnership greatly amplified the impact of the PNZ campaign and extended its reach.

Saatchi & Saatchi as PNZ's advertising agency provided outstanding creative input into the development of the STTA campaign, embracing the campaign brief and showing unwavering commitment to the design, communication and delivery of message. Their enthusiasm for the project led to the engagement of Finch Productions who brought the campaign to life, along with Spark Foundry who assisted in wider media placement.


Funding

Marketing

With Paris 2024 on the horizon, Paralympics New Zealand (PNZ) together with advertising agency Saatchi & Saatchi, set out to create a marketing campaign that would celebrate, excite and inform. Delving inside the minds of New Zealand's Paralympians and Para athletes the marketing campaign encouraged Kiwis to look at our Para athletes through a different lens.

Paralympians #164 Cameron Leslie MNZM, #195 Anna Grimaldi MNZM and #229 Devon Briggs were heroes of the campaign, titled 'We'll Give You Something To Talk About'.

Featuring a series of visually striking and thought-provoking films, Paralympians were shown doing what they do best, using the negative comments they have heard as fuel to push further and faster. The campaign featured long form interviews and challenged people to look at the Para athlete first, disability second.

Launched with the Cameron Leslie film in early July 2024, an opportunity to share how he struggled to get people to believe in him early in his career: "Disability can so often be talked about in whispers and behind people's backs. Those of us with disabilities go through life proving people wrong and sport became my way to do this". For Anna Grimaldi, her motivation was to challenge perceptions around being 'normal'. As she said, "What even is 'normal'?

Meanwhile, for Devon Briggs, the campaign brought to life the names he was called as a kid and feelings of being worth less than others.

With aspirational stories of resilience and determination, and the generous support of media partners TVNZ, NZME and LUMO, the campaign featured static and film creative executed across multiple channels including TV, radio, social media, outdoor billboards and news media. PNZ shared campaign content with TVNZ which ensured a cohesive broadcast campaign. The campaign surpassed expectations, achieving outstanding results and increasing public engagement with the NZ Paralympic Team. It cannot be understated the overwhelming number of comments, feedback and positive

PNZ also acknowledges NZME and Flight Centre for joining PNZ in a radio promotion, giving away flights for two and seven nights accommodation, with tickets and hospitality at the Paris 2024 Paralympic Games. The fabulous prize was won by Heather Walker from Nelson, a deserving winner who volunteers in her community providing sport for disabled people.

Honoco research

Paralympics New Zealand (PNZ) commissioned sport research agency Honoco to undertake brand monitoring and analysis prior to and post the Paris 2024 Paralympic Games. With the launch of the NZ Paralympic Team brand in August 2023, Paris 2024 provided the opportunity to track both the Team brand, and the PNZ brand. PNZ and the NZ Paralympic Team share many common brand attributes, with Kiwi, Passionate and Inspiring represented strongly and often overindexing when compared to other sports organisations. PNZ is also seen by Kiwis as Innovative and Humble, and the Team brand delivers strong attributes of Brave, Influential and Transformative.

Following Paris 2024, the NZ Paralympic Team continues to have the third highest affinity level across sporting brands in Aotearoa New Zealand, behind only the New Zealand Olympic Team (NZ Team) and the All Blacks. The Team's performance at Paris 2024, along with the provocative marketing campaign 'We'll Give You Something to Talk About', increased the nation's love for the Team to an all-time high, rising from sixth to fourth among a list of the most loved sports brands in Aotearoa New Zealand*. The Team's affinity is now +20% higher than the sport industry benchmark aggregate.

Digital and Communications

Social Media

The digital channels of Paralympics New Zealand (PNZ) enjoyed a record-breaking year in 2024, with significant growth across all our social media channels in viewership, following and engagement led by the Paris 2024 Paralympic Games.

A fresh digital-first and content focused approach gave unparalleled coverage of the NZ Paralympic Team through video content, engaging imagery and news articles hosted on PNZ'S platforms in the countdown to, during and post Paris 2024. During the Games PNZ achieved more than 12 million impressions on Facebook and Instagram, with another two million impressions on YouTube.



The world-class photography from Getty Images remained the most popular stream of content during this period, but video content emerged as a new favourite for audiences, as PNZ shared the magic of medal ceremonies and the emotion of post-event interviews with Paralympians and their families.

The time and care fans took to engage on both organic and paid digital activity



demonstrated their genuine admiration and aroha for the NZ Paralympic Team.

PNZ digital channels from January to December 2024 saw an increase of 6,700 Facebook followers and 3,400 Instagram followers.

Website

The PNZ website acted as a hub for all Paralympic Games activity. Featuring a competition schedule, profile of the full NZ Paralympic Team, a homepage medal tally, and regular performance updates and daily wraps of the competition. The website hosted 140,000 sessions by fans of the NZ Paralympic Team and appeared in more than 17 million search results.

Website traffic has continued to grow compared to 2023 and previous summer

Paralympic Games years. An encouraging year of growth for PNZ creates a strong platform to continue to leverage in 2025, and for the countdown to the Milano Cortina 2026 Paralympic Winter Games.



Communications

PNZ published 71 media releases in 2024 and adopted a proactive approach to generating media both in the countdown to the Paris 2024 Paralympic Games and post-Games.

The total number of media mentions for the year across TV, radio, print and online totalled 4,048 while during Paris 2024 PNZ fielded more than 90 media inquiries and the NZ Paralympic Team gained more than 2,000 media mentions.

Both the Farewell event in July 2024 and the Welcome Home event in September 2024 garnered positive media with several key media outlets, including 1News present at both. Other media success stories included a series of pre-Games features which appeared on 1News with reporter Victor Waters and a series of features with LockerRoom.

Post Games, PNZ proactively set up a four-part series of long-form features with SENZ Radio, a trio of features with Paralympians for Woman's Day, and organised features on 1News for both Paralympians #195 Anna Grimaldi MNZM and #208 William Stedman.

Governance

Governance Report 2024

Key outcomes for 2024

NZ Paralympic Team oversight

In Paralympic Games years, governance oversight of the NZ Paralympic Team across the PNZ Board and sub-committees is central. This year with the Paris 2024 Paralympic Games was no different, ensuring policies, procedures and financial sustainability were monitored to ensure the best support was provided to the NZ Paralympic Team. The work continues in the review phase from the Paralympic Games campaign.

Strategic Plan oversight

While providing oversight around Paris 2024, Paralympics New Zealand (PNZ) remained focused on ensuring that work continues toward the delivery of the PNZ Strategic Plan to 2032 in terms of a sustainable pathway to the Paralympic Games, driving social change and ensuring our long term financial sustainability is in place.

Para athlete representation

The Board is pleased with how the PNZ Athletes' Council is operating and seeks a permanent and constituted Para athlete representative on the PNZ Board. Paralympians and Para athletes completed a survey to consider options, and agreement was reached with the PNZ Athletes' Council on a way forward. The recommended PNZ Board composition, including Para athlete representation, will be voted on by PNZ Members as part of the proposed changes to the PNZ Constitution in 2025.

PNZ Constitution review

In response to the changes of the Incorporated Societies Act 2022, PNZ commenced a full review of the PNZ Constitution. An updated PNZ Constitution will be presented to PNZ Members for consideration and acceptance at the 2025 PNZ Annual General Meeting.

Te Ao Māori cultural competency

The PNZ Board continued a Te Ao Māori journey under the guidance of Jim Mather and his colleagues at Mather Solutions. PNZ acknowledges and recognises Te Tiriti o Waitangi and the importance of expanding cultural competencies as a PNZ Board and as an organisation, essential to provide better representation and service to the Para sport community in Aotearoa New Zealand. In June 2024, the PNZ Board joined the New Zealand Olympic Committee (NZOC) Board in Ōtautahi (Christchurch) to receive the pounamu taonga from Ngāi Tahu, for the NZ Paralympic Team competing at the Paris 2024 Paralympic Games.

New Board member

Dr Graeme Maw was appointed in July 2024, replacing Mark Elliott who resigned at the end of 2023. Graeme brings a wealth of experience in national and international high performance sport coaching in swimming, cycling and triathlon.

Board Vacancies

Three Board members' terms end in January 2025, with two Board members terms up for renewal. The Board appointment process was conducted in Q4 2024 and election process in place January 2025. Dr Catriona McBean reached the maximum number of terms and will retire from the PNZ Board at the end of January 2025.

2024 Financial Report

Framework

The Financial Report reflects operations during the twelve months ended 31 December 2024, reported as a Tier 2 entity, with specific notes and disclosures required.

Result

The 2024 period resulted in a surplus of \$355k, compared to a surplus of \$215k in the 2023 period. An amount of \$217k in unrealised capital gains in the PNZ investment fund has been included in income.

Key Facts

Key facts that contributed to the revenue of \$5.4m, compared to 2023 revenue of \$3.8m, are as follows:

- Fundraising and Sponsorship income of \$2.1m
- Other Grant income of \$312k
- Donations and Postal Appeal income of \$26k
- High Performance, Paralympic Games and Strengthen and Adapt income of \$2.3m

- Governance costs of \$102k includes travel, Board fees and development expenses
- Commercial and Marketing costs of \$982k includes events, value in kind expenses
- High Performance, Paralympic Games campaign and Strengthen and Adapt costs of \$2.7m.

Total Assets \$6.358m

Total assets include cash and investments of \$6.154m, property, plant and intangible assets \$105k, and prepayments \$59k.

Total Liabilities \$919k

Total liabilities include accounts payable \$198k, special purpose funds \$55k, employee entitlements \$146k and income in advance \$519k.

Legacy

Distributions have been made in the year for a total of \$36k, in line with the distribution criteria ratified by the PNZ Cyril Smith Legacy Funds Sub-Committee.

Ratios

Cash reserves and short term investments provides a coverage at 3.84 times the amount of our liabilities, and a liquidity ratio of 3.95. PNZ can meet its obligations.

NOTES TO THE FINANCIAL STATEMENTS FOR THE 12 MONTHS ENDED 31 DECEMBER 2024

1. Reporting Entity

The reporting entity is Paralympics New Zealand Incorporated (PNZ), an Incorporated Society under the Incorporated Societies Act 1908 and a Charitable Organisation registered under the Charities Act 2005. The financial statements are presented for the twelve months ended 31 December 2024. The comparative financial statements are for the twelve months ended 31 December 2023.

The financial statements and the accompanying notes summarise the financial results of activities carried out by PNZ. PNZ oversees the implementation of two High Performance Para sports programmes and is the National Paralympic Committee within New Zealand.

The financial statements have been approved and were authorised for issue by the Board on the date specified in the Statement of Compliance and Responsibility.

2. Statement of compliance

The financial statements have been prepared in accordance with Generally Accepted Accounting Practice in New Zealand ("NZ GAAP"). They comply with Public Benefit Entity Standards Reduced Disclosure Regime and other applicable financial reporting standards as appropriate that have been authorised for use by the External Reporting Board for Not for Profit entities. For the purpose of complying with NZ GAAP, the entity is a public benefit entity and is eligible to apply Tier 2 PBE Standards on the basis that it does not have public accountability and is not defined as large.

The Board has elected to report in accordance with Tier 2 PBE Standards and in doing so has taken advantage of all applicable Reduced Disclosure Regime ("RDR") disclosure concessions.

The financial statements have been prepared based on the fact that the Board has assessed the entity to be a going concern. This assessment has been made based on the current level of reserves held, as well as the expectation of continued support by the New Zealand Government through High Performance Sport New Zealand (HPSNZ) and Sport New Zealand (Sport NZ), and other sponsors and donors.

3. Summary of Accounting Policies

The significant accounting policies used in the preparation of these financial statements as set out below have been applied consistently to both periods presented in these financial statements.

3.1 Basis of measurement

These financial statements have been prepared on the basis of historical cost, except for investments in equities and fixed interest securities that are recorded at fair value.

3.2 Functional & presentation currency

The financial statements are presented in New Zealand dollars (\$), which is the entity's functional currency. All financial information presented in New Zealand dollars has been rounded to the nearest dollar.

3.3 Revenue

Revenue is recognised to the extent that it is probable that the economic benefit will flow to the entity and revenue can be reliably measured. Revenue is measured at the fair value of the consideration received. The following specific recognition criteria must be met before revenue is recognised.

Revenue from non-exchange transactions

Donations

Donations are recognised as revenue upon receipt and include donations from the general public, donations received for specific programmes, services or donations in-kind. Donations in-kind include donations received for goods and services and are recognised in revenue and expense when the service or good is received. Donations in-kind are measured at their fair value as at the date of acquisition, ascertained by reference to the cost that would be otherwise incurred by PNZ.

Grant revenue

Grant revenue includes grants given by the Government via HPSNZ, Sport NZ and other charitable organisations, philanthropic organisations and businesses. Grant revenue is recognised when the conditions attached to the grant have been complied with. Where there are unfulfilled conditions attaching to the grant, the amount relating to the unfulfilled condition is recognised as a liability and released to revenue as the conditions are fulfilled.

If there are no conditions attached to the Grant, it is recognised when the money is received.

Fundraising revenue

Fundraising revenue includes donations given to the organisation. Fundraising revenue is recognised when the cash is received. As there are no conditions attached to the revenue, the funds are recognised as revenue immediately on receipt.

Legacy revenue

Legacy revenue is recognised in the period it is received.

Revenue from exchange transactions

Membership Fees

Subscriptions received from members are billed annually and recognised as revenue.

Sponsorship Income

Revenue is recognised on a straight-line basis where the benefit to the sponsor is received over the term of the contract.

Interest and dividend income

Interest revenue is recognised as it accrues, using the effective interest method. Dividend income is recognised when the dividend is declared.

3.4 Financial instruments

Financial assets and financial liabilities are recognised when PNZ becomes a party to the contractual provisions of the financial instrument.

Financial assets

Under IPSAS 41, financial assets are classified into the following categories:

- Amortised Cost: This category includes financial assets that are held to collect contractual cash flows. They are measured at amortised cost using the effective interest rate method.
- Fair Value through Surplus or Deficit (FVTSD): Financial assets that do not meet the criteria for classification in the other categories are classified as FVTSD. They are measured at fair value, and all changes in fair value are recognised in surplus or deficit.

The classification of the financial assets is determined at initial recognition.

PNZ financial assets at amortised cost include: cash and cash equivalents, short-term investments, receivables from non-exchange transactions, receivables from exchange transactions.

Fair value through Surplus or Deficit

Financial assets at fair value through Surplus or Deficit include financial assets held for trading and financial assets designated upon initial recognition at fair value through surplus or deficit. PNZ's investment portfolio is designated in this category as its performance is evaluated on a fair value basis.

Investments recognised in this category are carried in the statement of financial position at fair value with changes in fair value recorded in the statement of comprehensive revenue and expense.

Receivables

Receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. Short term receivables are recorded at the amount due, less an allowance for expected credit losses (ECL). This allowance is calculated based on lifetime ECL. In measuring ECL short term receivables have been assessed on a collective basis as they possess shared credit risk characteristics. They have been grouped based on the days past due. Short term receivables are written off when there is no reasonable expectation of recovery. No loss allowance for expected credit losses has been recognised because the estimated 12-month expected loss allowance for credit losses is trivial.

Financial liabilities

Financial liabilities include trade and other creditors (excluding GST and PAYE), employee entitlements, loans and borrowings and deferred income (in respect to grants whose conditions are yet to be complied with). All financial liabilities are initially recognised at fair value (plus transaction cost for financial liabilities not at fair value through surplus or deficit) and are measured subsequently at amortised cost using the effective interest method.

3.5 Cash and cash equivalents

Cash and cash equivalents are short term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value. Although cash and cash equivalents at 31 December 2024 are subject to the expected credit loss requirements of PBE IPSAS 41, no loss allowance has been recognised because the estimated loss allowance for credit losses is trivial.

3.6 Investments

Short term investments comprise term deposits which have a term of between 90 days and twelve months and do not fall into the category of cash and cash equivalents.

Long term investments comprise of investment funds that are held at fair value through Profit or Loss and term deposits which mature twelve months or more post balance date.

Although investments at 31 December 2024 are subject to the expected credit loss requirements of PBE IPSAS 41, no loss allowance has been recognised because the estimated loss allowance for credit losses is trivial.

3.7 Property plant & equipment

Plant and equipment are measured at cost less accumulated depreciation and impairment loss. When the asset is acquired through a non-exchange transaction, the cost is measured at its fair value at date of acquisition.

Depreciation is charged over the useful life of the asset using the following depreciation rates:

3.8 Intangible Assets

3.9 Leases

Payments on operating lease agreements, where the lessor retains all of the risks and rewards of ownership of an asset, are expensed as per the lease agreement over the lease term.

3.10 Employee Benefits

Liabilities for salaries and annual leave are recognised in surplus or deficit during the period in which the employee provided the related services. Liabilities are measured at the amounts expected to be paid when the liabilities are settled.

3.11 Income tax

Due to its charitable nature, PNZ is exempt from income tax.

3.12 Goods & Services Tax

These financial statements are prepared net of the amount of GST except for receivables and payables, which are stated with the amount of GST included.

The net amount of GST recoverable from or payable to the Inland Revenue Department is included as part of receivables or payables in the statement of financial position.

3.13 Equity

Equity is the community's interest in PNZ, measured as the difference between total assets and liabilities. Equity includes the following components :

Accumulated Comprehensive Revenue and Expense

This represents the accumulated surpluses of PNZ since inception less transfers to other reserves.

Special Projects Reserve

A bequest was received from the estate of the late Cyril Smith. This legacy is to be applied to "Para athletes in the Canterbury region for their training and development and otherwise in accordance with the objects of Paralympics New Zealand". A separate reserve has been created. Annually an assessment is made by the Board as to the amount of investment income received by PNZ that relates to this balance. That amount is transferred to the reserve annually. Expenditure relating to the objects of the request is deducted from the revenue.

4. Significant accounting judgements, estimates and assumptions

Judgements

In the process of applying the PNZ accounting policies, management has made the following judgements, which have the most significant effect on the amounts recognised in the financial statements.

Useful lives

The useful lives and residual values of assets are assessed using the condition and nature to determine potential future use and value from disposal.


